Present

2. Minutes of AGM 2011

4. Financial report

The report was presented by Graham Vernon. In discussion, points were raised about the desirability of further recruitment, more publicity and higher ticket sales. A number of suggestions were advanced as to how this might be done. In response to questions about the recent increase in the cost of the concert venue, the chair responded that the committee kept this and other costs under review, but noted that other suitable venues had not been identified which were cheaper. He noted All Saints' flexibility in allowing reduction of fees when the crypt was in use during rehearsals.

The report was adopted unanimously.

The chair thanked Graham Vernon on behalf of the orchestra for his work as Treasurer and his contribution to the strengthening of DSO's finances.
